



## Arizona Tax Credit Questions and Answers

Q. What is the Arizona Charitable Tax Credit?

A. The Arizona Charitable Tax Credit is a dollar-for-dollar credit you can receive on your Arizona state taxes. Single and head of household filers can receive a dollar-for-dollar tax credit up to \$400, or up to \$800 if you are filing jointly.

Q. Can I contribute to more than one charitable organization?

A. Yes! The total Charitable Organization Credits you may claim is \$400 per individual or \$800 for married couples filing jointly.

Q. Tax credit or tax deduction?

A. The difference between the two is that a tax credit reduces the amount you owe to the state, dollar-for-dollar. A standard charitable deduction only reduces taxable income.

## Arizona Charitable Tax Credit

Put your Arizona tax dollars to work for Ryan House!

Under the Arizona Charitable Tax Credit (also known as the Working Poor Tax Credit), you can give up to \$800 if married and filing jointly and up to \$400 as an individual. You get the entire amount back as a 100 percent state tax credit. This is available in addition to the public and private school tax credits. You do not have to itemize deductions to claim this credit on your state tax return.
